## “We’re Going to Do Something About This...”

Hardeman County Mayor Jimmy Sain must be seeing garbage in his dreams.

The early days of his administration were marked by trips to Nashville to answer questions on the county’s handling of solid waste and combatting littering has now become a priority.

“We’re going to do something about this,” he said of the illegal dumping on Oak View Loop discovered on March 22. “We are going to prosecute.”

Figuring out who did the dumping may be as easy as a little detective work.

Hardeman County Director of Solid Waste Kenny Brown cites Tennessee Code Annotated 39-14-502.

*Whenever litter discovered on public or private property is found to contain any article or articles, including, but not limited to, letters, bills, publications, or other writings that display the name of a person in such a manner as to indicate that the article belongs or belonged to that person, the trier of fact may, in its discretion and in consideration of the totality of the circumstances, infer that the person has committed littering.*

Brown adds that punishment depends on the amount of littering, i.e. less than five pounds is a Class C Misdemeanor punishable by a fine of \$50, imprisonment of 30 days, or both, and up to 40 hours community service.

In extreme cases, fines and imprisonment could go as high as \$3,000 and up to a year in jail.

“Illegal dumping and littering have become a significant problem in Hardeman County. Not only is it an eyesore, but it impacts our community both environmentally and economically,” added Brown. “We are working with local law enforcement agencies to crack down on this problem, but more enforcement will not solve the problem. We are also developing a litter program for students and a marketing program in an effort to increase awareness.”

Brown said reports of littering or illegal dumping are welcomed at his office by calling 731-658-2884.

### Blackjack on the Hatchie River?



A loophole in the gambling laws in the state of Tennessee may allow for gambling on even the smallest of rivers and streams in the state.

Tennessee code 21-A-10 was changed last year to allow fishermen and guides to charge for tours of rivers and streams in the state, but according to legal experts, it may just open the door for legalized johnboat gambling within the state.

"The way the law is worded allows for all sorts of commerce on any size body of water," said Ed Loseman of the Law Firm of Gorman, Loseman, and Black. "We think gambling may fit into the definition. And until someone challenges it in court, we are advising our clients to go forward."

A company in East Tennessee is doing just that, marketing small crafts that will hold a blackjack table, dealer, waitress, four patrons, and a live well. Frequent trips back to land will let clients hit the ATM, freshen up, and stock up on food, drinks, and crickets.

While the state of Tennessee may object at first, the taxes on the winnings will be taken before the boat will be allowed to come back to land, and could bring an estimated \$10 million per year to the tax coffers. In addition, an estimated five more million dollars in fishing licenses, which will be a mandatory purchase for any would-be gambler, could be collected.

It will also help bring back jobs to the state as those trained as fishing guides/blackjack dealers will rejoin the workforce.

Rural counties, which often have streams and rivers that would be ideal for this type of commerce, could benefit the most. These counties are continually searching for more money for schools and rising costs, and have considered ideas such as cigarette advertising on school buses and including bicycles in the wheel tax, among other things.

An opinion by the Tennessee Attorney General on this issue is expected by April 1. Well, probably not. April Fool!

## Lake Vonda Resort to Be Sold



Local realtors Bobby Sain and Larry Childers have listed Lake Vonda Resort this past month.

Lake Vonda is a multi purpose agricultural and recreational property located off Highway 125 between Bolivar and Middleton.

The current use of the property is multi-purpose, with almost 400 acres in farmland and about 50.3 acres in recreational development property. The recreational property includes a Main (Sales) Office Building, Multi Pavilions, 2 Residential Homes and 7 Rental Cottages, 6 lakes/ponds (1 which is approximately 30 acres in size and 5 smaller lakes ranging from .38

acres to 2.5 acres).

The recreational area also includes a commercial swimming pool, commercial playground equipment, bath houses, recreational building, and sidewalks. The resort has over 46,700 square feet of concrete parking area, over 1.4 miles of paved roads, 1.2 miles of concrete walks (12' wide) throughout the development and over 4,000' of iron fencing and over 3,000' of retaining wall around lake. The resort is built around the approximately 30 acres lake known as "Lake Vonda". The Hardeman County Tax Assessor is showing the resort to consist of

33.79 Acres Woodlands, 14 Acres in Commercial Resort Development, and 2.51 acres in Non-Productive Property for a total of 50.3 acres. The land is broken down by 119.4 Acres in Row-Crop, 33.7 Acres in Pasture, and 195.37 Acres in Woodlands and 18.34 Acres in Non-Productive property for a total of 366.81 acres. The farm's present use is vacant. It was last occupied as a Resort Development. The cropland is worked by a local farmer. Other possible uses would be of wide range including resort development/retreat, Church Camp, or recreational park.

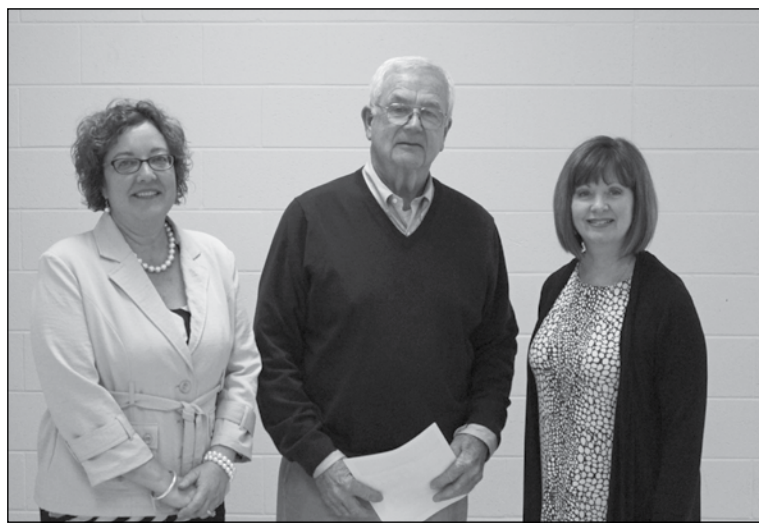

A New Believe in Bolivar is Launched

The City of Bolivar was chosen to be part of a program that will focus on helping three communities in Tennessee take on needed projects and had a public forum to consider direction on March 24.

Tennessee USDA Rural Development recently approached three small cities in Tennessee about their interest in participating in the Rural Town Recovery initiative. Through this initiative - Rural Development will work with selected small communities to help address their decaying and blighted neighborhoods. The cities chosen for the project are Springfield, Paris and Bolivar. These cities have neighborhoods with vacant and abandoned houses; houses that are in significant disrepair and also decaying infrastructure, such as broken sidewalks; city parks that are distressed and streetlight/signage problems. Through the partnership with these cities, USDA will work together to find resources to help meet the needs of homeowners, neighborhoods and community. This process includes coordinating activities involving a Community Forum; conducting Door to Door surveys of the homeowners and implementing neighborhood clean-up projects and volunteer home repair for the elderly and disabled.

Rural Development anticipates being able to work with local developers to construct new homes



on vacant lots and subsequently provide affordable financing options for first time homebuyers. In addition, funds are available for homeowner repair through the USDA loan and grant program. 100% financing is available for homebuyers to buy or build new housing. Home repair loans and grants are also available. Grants are available to qualifying homeowners over the age of 62 of up to \$7,500. Bobby Goode, State Director for USDA Rural Development, states that “this is a long term process that will evolve differently in each of these three town locations. It is our mission to help these rural communities thrive and we feel that our agency program support

coupled with both internal and external partnership resources can be effectively combined to help these towns start to reverse the slow decay that many of their neighborhoods have been experiencing over the years”.

“Our goal is to assist these three rural communities with the tools they need to create future wealth and growth” Lisa Hewitt-Cruz, SFH Team Leader, USDA.

Now that the Rural Town Recovery Initiative has kicked off - each of these selected locations has already begun the process of conducting the Door to Door surveys, Community Forums, establishing Focus Groups, and scheduling their neighborhood Clean-Up activities. We look forward to the future success that will be evident from the efforts of all partners involved.

County Unemployment Rate Dips Again

Hardeman County saw their unemployment rate dip to 6.0% in February, down from the 6.7% figure for the county in January. The rate puts the county at 66th highest in the state, their best ranking in more than seven years.

County unemployment rates for February 2016 show the rates decreased in 93 counties, increased in one, and remained the same in one county.

**TN Dept of Labor fighting fraud:** Tennessee Department of Labor & Workforce Development has implemented LexisNexis InstantID from LexisNexis Risk Solutions as an added measure to

prevent people from fraudulently applying for unemployment benefits.

LexisNexis InstantID, integrated into Tennessee’s unemployment insurance claims process, helps to confirm the applicant’s identity before processing their unemployment insurance claim. The program uses identity analytics that combine billions of public records and advanced linking technology to generate a knowledge-based quiz, designed so only the true individual would be able to answer the questions. This process of verifying and authenticating the applicant, called identity proofing,

enables Tennessee to know whether the individual filing the claim is truly the owner of the identity.

Since implementing LexisNexis Risk Solutions on December 15, 2015, more than 75,000 claimants have engaged in the identity verification process. Eighty-percent of these claimants passed and were able to submit an unemployment claim. When the system prevents a person from filing, they must contact TDLWD for assistance. Less than half of the 20 percent who fail to answer the security questions actually made contact with TDLWD to correct any issues.



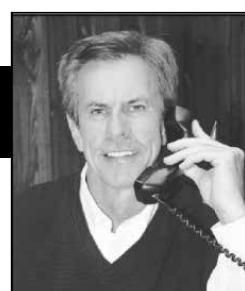

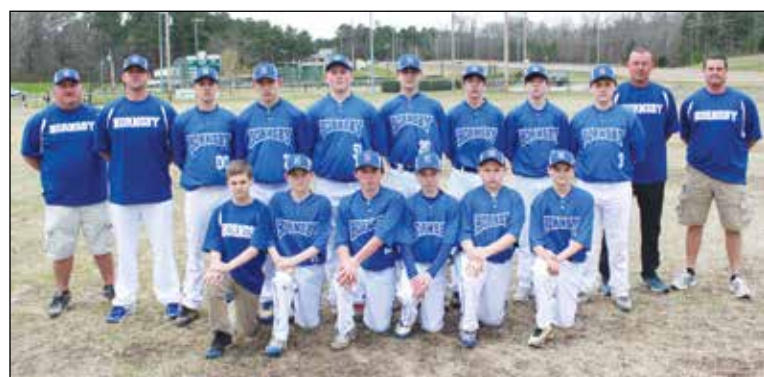
The county tournament will begin at 11:00 a.m. with the first and third seeds playing the first game.

## Star PT Hardeman County Sports Notes

Former Tennessee Coach Phillip Fulmer will speak at the Bolivar Central High School Auditorium on May 12 at 6:00 p.m.

He will be the keynote speaker for the Bolivar Central Hi-Lite Reel Award Show.

He served as head coach of the Tennessee Volunteers football team from 1992 to 2008, compiling a 152-52 record. He is best known for coaching the Volunteers in the first ever BCS National Championship Game in 1998, defeating Florida State University. Fulmer was the Volunteers' 20th head football coach.

At the end of his tenure at Tennessee, Fulmer had the second-highest number of wins of any head coach in Tennessee history, 21 behind Robert Neyland. Fulmer also was the third coach in Tennessee history to win a claimed national championship. His 1997 and 1998 teams won consecutive SEC championships. In recognition of his accomplishments at Tennessee, Fulmer was inducted into the College Football Hall of Fame in 2012.

As a player at UT, Fulmer garnered All-Southeastern Conference honors at offensive guard. Fulmer helped Tennessee to a 30-5 record from 1969-1971, where he played for coaches Doug Dickey (who returned to UT as athletic director and hired Fulmer as the Volunteers' coach) and Bill Battle. 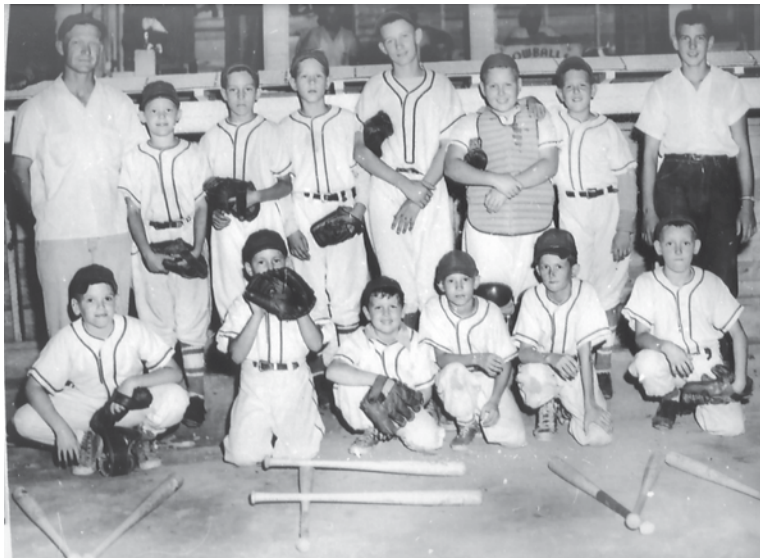



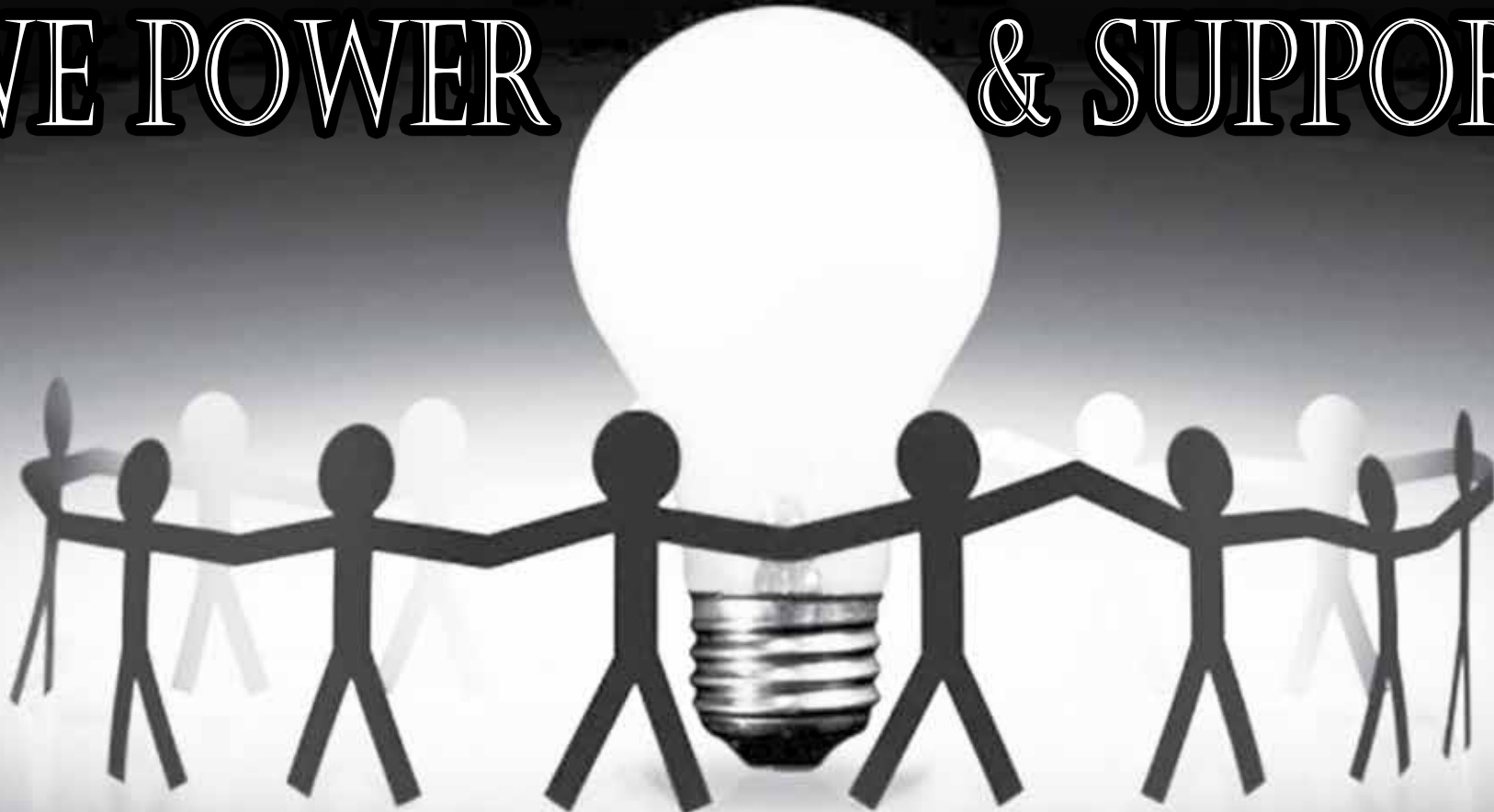

# WHY BUY LOCALLY?

With current market conditions, it has become increasingly cheaper to buy distantly produced goods, despite the increased costs of packaging, transport, inspection, and associated expenses. However, along with lower prices comes the added cost of repercussions on the environment and impacts on the economic well being of your community. Here are some shocking stats & quick facts about buying local goods.

## Import & Shipping Statistics

- The U.S. imports \$2.2 trillion worth of products yearly from over 150 countries.
- Aircraft transport has greater fuel consumption and greenhouse-gas emissions per mile than any other mode of transport.
- Transportation by shipping produces emissions of 1 billion metric tons of CO2 and uses 11 billion gallons of fuel per year internationally.
- The amount of sulfur oxide pollution that comes from the 15 largest ships equals the combined amount coming from all the cars in the world. (2007)

## Waste & Packaging Statistics

- Food processing uses a lot of packaging, which is necessary for large farms to keep food from spoiling as it is transported and stored. But this packaging is often difficult or impossible to reuse or recycle.
- The EPA has estimated that the U.S. produced 11.9 million tons of plastic packaging, and over 90% of this went to a landfill after being used just once. (2003)
- Most food in the U.S. is picked a week in advance of reaching a store. Typically, a carrot will travel 1,838 miles to become part of a meal.
- A 10% shift of the produce to local use from one state's farms would save 310,000 gallons of fuel on an annual basis, and would also reduce CO2 by 7.3 million lbs. (Iowa 2010)

## Transportation Statistics

- Trucks and locomotives are responsible for 25% of smog-causing pollution and the majority of the cancer threat posed by air pollution in some urban areas.
- The EPA reports that trucks spend 3,221 of their 6,816 hours on the road each year at an idle. 1.2 billion gallons of fuel and about 200,000 tons of nitrous oxides are expended each year by transport trucks idling at rest stops.

## Big Box Chains vs. Local Businesses Statistics

- Throughout the United States, only about 33.6% of the revenue from national chains is reinvested into the community, which is very low compared to the 64.8% return from local businesses. (2009)
- A study in Austin, Texas found that \$100 spent at a local bookstore produced \$45 worth of local economic activity, and \$100 at the chain store Borders brought back only \$13.
- National chains often bring loss of employment. The opening of a Wal-Mart reduces retail employment by an average of 150 jobs in the county of its location.
- Local businesses are usually established in city centers, instead of on the margins of communities like large chains, so they contribute less to pollution, congestion, habitat loss and urban sprawl.

If the people of an average American city were to shift 10% of their spending from chains to local businesses, it would bring an additional \$235 million per year to the community's economy.

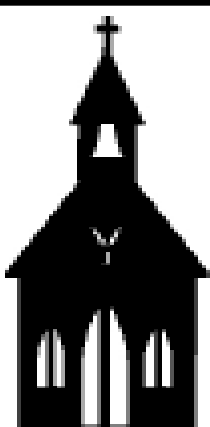

## Hardeman County Drug Court Honors First Graduates

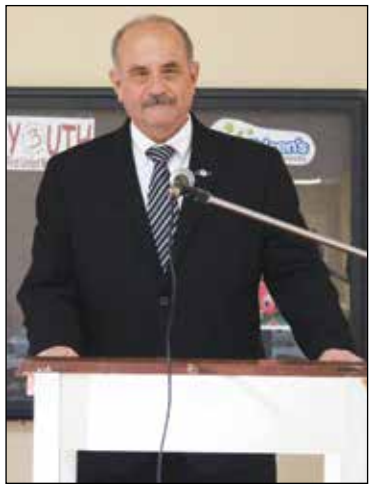
Four graduates of the first Hardeman County Drug Court were honored by 96 attendees at the First Methodist Church on March 22.
