Seven Commissioners Out of Party?

A Hardeman County democratic party representative says seven county commissioners that ran as democrats in 2014 should look for a different donkey to ride in 2018.

"We found 7 current commissioners who ran as Democrats in the past, that now, would not qualify as Democrats," said the letter to the editor from Meryl Rice, who is the District 26 Tennessee Democratic Party Executive Committeewoman.

Other than the commissioners, there is apparently good news for other county officials, including Hardeman County Mayor Jimmy Sain.

"Except for those 7, all of the current Democratic county officials would qualify," the letter went on to say, without naming the seven commissioners. *For the entire letter and the editorial response, see B5.*

Rice's letter says a "bona fide"

democrat is someone who has "voted Democrat 3 of the last 5 state/national primaries."

Rice's letter to the editor was in response to an editorial response to her letter in the April 13 issue of the *Bulletin Times*, which was a response to the April 6 *From the Other Side of the Desk*.

In 2014, Hardeman County Mayor Jimmy Sain won the Democratic Primary over incumbent Willie Spencer. Sain and the

county commissioners voted by a 2/3 margin in 2016 to do away with partisan political primaries in county elections, sending a private act to the state house, which was defeated by acclamation. Normally, any private act sent by a county gets rubber stamp approval and comes back to the county requiring a second 2/3 majority to pass into law.

Debate Questions Made Public

The list of questions candidates will face in the 2017 Bolivar Mayor's Debate was released to the candidates on April 18 in anticipation of the April 25 debate between incumbent Barrett Stevens and challenger Julian McTizic at the Bolivar Municipal Center Courtrooms at 6:00 p.m.

The evening will begin with any city council candidates who wish to speak for two minutes, followed by a 10 minute recess.

The Mayor's Debate will begin with each candidate given two minutes for an opening statement. A coin flip will determine who will go first in opening statements. The loser of the coin flip will go first in the closing statement, which will also be two minutes. In between, the candidates will have six questions to debate.

WMOD Radio (96.7 FM) and County Journal Television (www.wmodradio.com) will broadcast the evening's events.

The Mayor of Bolivar for the next term and four Bolivar city council positions will be elected on May 16.

Early voting in the Bolivar City Election is scheduled for April 26-May 11. Also on the ballot is a referendum question for the city of Middleton. A sample ballot is on B5 as well as the questions for the debate and other election information.

Hardeman County Remembered by Lisa Coleman

The advent of the trains and train travel changed lives for people; a journey across country that had previously taken weeks of arduous and dangerous travel by wagon could now be done in a matter of days. Traveling on the rails was long, dusty, and dirty; but those were usually minor inconveniences when compared to the excitement of the journey itself. Many of the passenger trains, unlike their later counterparts, did not have dining cars. Towns that were fortunate enough to be along the rail lines quickly remedied that situation. Hotels would spring up and provide not only lodging for travelers, but meals as well. It was not unusual for the railroads to become involved in building the hotels, and that's how one hotel in our county came into existence. The Commercial Hotel in Grand Junction was built in the 1850's and was originally known as the Railroad Hotel because of its location at the crossing of the Memphis and Charleston and the Illinois Central Railroads.

This hotel took in almost an entire block in town and had a large dining room to accommodate train travelers at meal times. The three-story structure had rooms on the second and third floors and the dining room, sitting rooms, baggage, rooms, a telegraph office, and a barbershop, among others, on its first floor. The hotel became known as the Commercial Hotel



around the turn of the 1900s and it was managed for many years by Anthony and Cynthia McLeran. Mr. McLeran, a native of North Carolina, found his way to North Mississippi and had a mercantile business there. He enlisted in the Confederate Army, Company C, 26th Mississippi Regiment; he surrendered at Appomattox and received an honorable discharge at Point Lookout, Maryland. After the war he returned to North Mississippi and came to Grand Junction with his wife and five children in 1902. The McLerans were active in the Presbyterian Church and in the Grand Junction community for many years. Sadly, the old hotel was torn down in 1923, ending an era for sure.

The group assembled on horseback around the hotel in this photo are guests who had come to town for the Field Trials in the early

1900s. Mr. Hobart Ames would frequently send a wagon to the hotel each day to pick up lunches for the riders. There must have been a great energy around this and other hotels in the town in February – the hiss and rattle of the train, the sounds of the riders talking to each other and to their horses, the sounds of the horses, and townsfolk watching and discussing it all.

When you drive across the train tracks, think about all the people from all over the country and the world who have come – and still do – to our part of the world every year for the Field Trials. And y'all, if you're in Grand Junction over the next few days, take a minute to listen for one of the world's most marvelous sounds – the beautiful sound of the train in the distance.

A Message from the Hardeman Co. Extension Office

What comes to mind when you hear the words physical activity? If you are like many, your thoughts may race to images of gym memberships, confusing workout equipment and intimidating classes. Yet, this does not have to be the case. Physical activity can be fun, simple, and with a little planning easy to fit into your daily routine.

Soghra Jarvandi, Assistant Professor with UT Extension, says adults should strive to begin or maintain a physically active lifestyle. "Adults should work toward at least 150 minutes of moderate physical activity per week, which is about 30 minutes of physical activity five times per week. That's the recommendation listed in the most recent Physical Activity Guidelines for Americans, published in 2008 by the U.S. Office of Disease Prevention and Health Promotion," states Jarvandi. "This activity can be anything you enjoy doing, and it does not have to involve any special equipment or gym memberships."

If you are not ready to take on 30 minutes of physical activity, five times per week, don't worry. According to Christopher Sneed, a Family and Consumer Sciences Specialist with UT Extension, it is okay to start small and work toward a longer-term goal of meeting the physical activity guidelines. "To get started", reiterates Sneed, "you can begin to think of ways to incorporate physical activity into your day whether at

home, at work or at play."

Jarvandi and Sneed offer these simple suggestions to get you started:

- At Home:
 - Exercise while watching television.
 - Use chores as a way to move more - clean the house or wash the car.
 - Walk the dog - not just watch the dog walk.
 - Play with the kids - splash in a puddle, dance, toss a softball or kick around a soccer ball.
 - Push the baby stroller.
- At Work:
 - Replace your "coffee break" with a brisk 5- or 10-minute walk.
 - Walk with a co-worker during lunch.
 - Try walking meetings.
 - Use stairs instead of the elevator.
 - Park your car a little further from the building's entrance.
 - Get on and off the bus a couple of blocks away from your work.
- At Play:
 - Walk up and down the soccer or ball field sidelines while watching your kids play.
 - Take a nature walk.
 - Plant and take care of a garden.
 - Instead of calling friends, plan to take a walk together and chat.
 - Start your day with some gentle stretching.

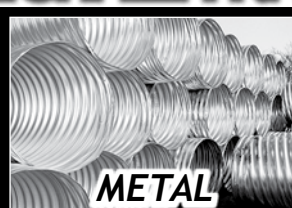

Trust the Maker, Not the Path

In my recent travels, I've come to understand an important principle. We must trust our Maker on this path, not the path we've planned. The most important decisions my friends and I have made have been unquestionably altered from what we envisioned. We plan one thing, and God leads us to another. The path seems haphazard at times, but God's plans are precise and purposeful. God doesn't tend to build a broad interstate for everyone to follow, but instead, He weaves a delicate, strong thread like a divine spiderweb. I have witnessed this intricate plan in my own life at times, even when I was oblivious to most of it.

One of my dear friends served as a missionary in Korea. His family was instantly immersed in a language and culture he didn't know. He worked diligently to care for those around him, but in the meantime, found himself in a lonely place. He and his wife had three children and a fourth unplanned child was on the way. The neighbors and members of the church there all cautioned him to keep a small family with fewer responsibilities. In fact, the culture deemed it unwise to have more than two children. The families all around him, literally thousands, had only one or two children.

My friend's wife miscarried their fourth baby, and they were deeply grieving the loss. My friend said he never felt more alone than the moment he realized nobody in the community understood their loss. They felt it was almost convenient that they were able to have a smaller family. One particularly close Korean friend came to their home and prayed for the family. She then ad-

mitted "I am very sad because you are very sad. I'm sorry I don't understand your sadness, but I feel sad that you are sad." That was the moment that he felt nearly abandoned in this foreign land. He decided to go to a Western church service that weekend and stay for the prayer service. The church found, during a prayer time, what had happened. My friend got an understanding embrace and an offer to plan a memorial service. They invited Korean friends, and the resulting service helped them to grieve the loss of their child. A tree was planted in the baby's memory on the church grounds.

My friend soon realized that the population of the school where he taught was always one-quarter or at most one-third female. Each subsequent class revealed the same. After three classes, he questioned and found that the people practiced gender-based abortion. Wanting boys to carry on the family name, the families were limiting their family size and choosing to abort until they had a boy.

My friend had seen many lives changed by Christ in their time in Korea. The family, having another child on the way, decided it was time to move on to another mission field. A man from the community approached them as they prepared to leave. He held out his baby girl with a smile on his face. As my friend held her and saw her beautiful smile, the man said: "She is alive because of you." My friend looked at him, puzzled as to what he meant. "She is alive... (pointing at her) because of you! (pointing at my friend). This is my third child." He realized the process of mourning an unborn baby

Be an "Environmentally Friendly" Investor

On April 22, we observe Earth Day, a worldwide event focusing on protecting the environment. As a citizen of this planet, you may want to take part in Earth Day activities. And as an investor, you can learn some valuable lessons from the environmental movement.

Here are a few ideas to consider:
"Recycle" proven strategies. Over the past few decades, we have discovered ways of bringing new life to objects we would have previously thrown away. When you invest, you also don't need to discard things you've used before - such as proven investment strategies. Even more importantly, it might not be suitable for your needs, either because it's too risky or because you already own several similar stocks. "Hot" stocks aren't so hot if they aren't right for you.

Reduce "excess" investments in your portfolio. Environmentalists stress the need for all of us to reduce our "footprint" on earth - that is, we can help improve the environment by owning less "stuff." The same idea can also apply to investing. If you took a close look at your portfolio, you might find investments that you've held for years but whose purpose is no longer clear to you. Some may even be duplicates, or near-duplicates, of other investments. You might be able to improve your financial picture by getting rid of this "clutter." By selling investments you no longer need, you could use the proceeds to purchase new investments that may be far more effective in helping you meet your objectives.

Plant "seeds" of opportunity. Many Earth Day lesson plans for students emphasize the value of planting gardens and trees. As an investor, you, too, need to look for ways to plant "seeds" of opportunity so that you can eventually harvest the results. Specifically, look for those investments that, like trees, can grow and prosper over years and decades. Of course, growth-oriented investments carry investment risk, including the possible loss of principal. Yet, to achieve your long-term goals, such as a comfortable retirement, you will need some growth potential in your portfolio. You can reduce the level of risk by owning a mix of investments - including less aggressive vehicles, such as bonds - in your portfolio.

Each year, Earth Day comes and goes. But its messages have had a profound impact on generations of people interested in preserving our environment. And translating some of these lessons to the investment arena can have a powerful effect on your financial future.

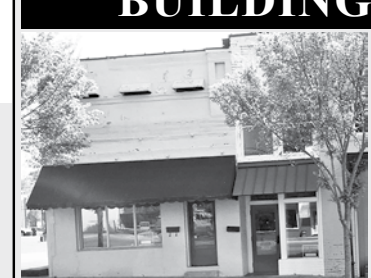

OPINION

It's futile arguing with the newspaper's publisher, but the facts don't change. Sure, it's lawful for Hardeman County to go non-partisan. The state election law provides for how to make that happen. Using a private act to force non-partisan elections though, is to undermine the state law which allows the county parties to work it out based on input from the candidates and the voters. Although the private act's intended target was the HCDP, it would have cut the legs out from under the Republican Party as well. It would have forced candidates to run non-partisan and kept them from claiming publicly that they were Democrats or Republicans. The private act was not the will of Hardeman County voters but of 11 county commissioners and the county mayor who were elected to uphold the law, not to make exceptions to the law.

The primary board is not unique to Hardeman County. Tennessee code, although not enforced, requires county primary boards for Democrats and Republicans. The five Hardeman County Democrats, appointed by the TNDP Executive Committee, don't "select" our candidates. They make recommendations based on the criteria set forth by state party by-laws that define "bona fide Democrat" as someone who has voted Democrat 3 of the last 5 state/national primaries. Many candidates meet that criteria. If not, they can run Republican or Independent. In fact, anyone can run Independent. A primary board "disenfranchises" no one, but assures voters that Democratic candidates are Democrats. Because there are fundamental differences in the way Democrats and Republicans approach governance, voters choose parties to align with and want to know how their candidates align.

Of the 22 county officials that we researched after your "only 1 person would be disqualified" comment, we found 7 current commissioners who ran as Democrats in the past, that now, would not qualify as Democrats. All 7 of them plus 2 Republicans and 2 Democrats (1 of the Democrats has been replaced) voted for the non-partisan resolution last year. Except for those 7, all of the current Democratic county officials would qualify.

We don't mind a good argument. But first, a little "Government 101." The private act passed by the county commission by an 11-5 margin WAS the will of the people of Hardeman County. The people elected representatives who voted for this private act. We live in a Representative Republic. By definition, how our elected leaders vote is the "will of the people." Even when it doesn't go our way.

If we have to first choose a party to choose our leaders, we are being disenfranchised. Without the party politics, county voters would have the opportunity to vote for every candidate they are eligible to vote for. And if a candidate wants to claim to be a democrat or a republican to impress would-be voters, they can advertise themselves as such.

Yes, there are fundamental differences between republicans and democrats. But not here in Hardeman County, not really. The platforms of the national parties are not in our decision wheelhouse. We do not have supreme court judges to filibuster, we do not decide reproductive rights, our border with McNairy County is open (even if where the 45 mph zone seems to start a little early), we can't declare war, etc, etc... We're just a group of people who, I'm pretty sure, want the same things for our county. Good roads, safe streets, good schools, and jobs. Saying we are somehow representative of national politics is, in our opinion, like a kid in the backyard with a ball and bat pretending he is at Yankee Stadium. Here in Hardeman County, if a person wants to know how a candidate "aligns," they can call him or her. County candidates don't need a party label to hide behind. They are our friends and neighbors.

And as far as your third paragraph goes, we hope you read the front page.

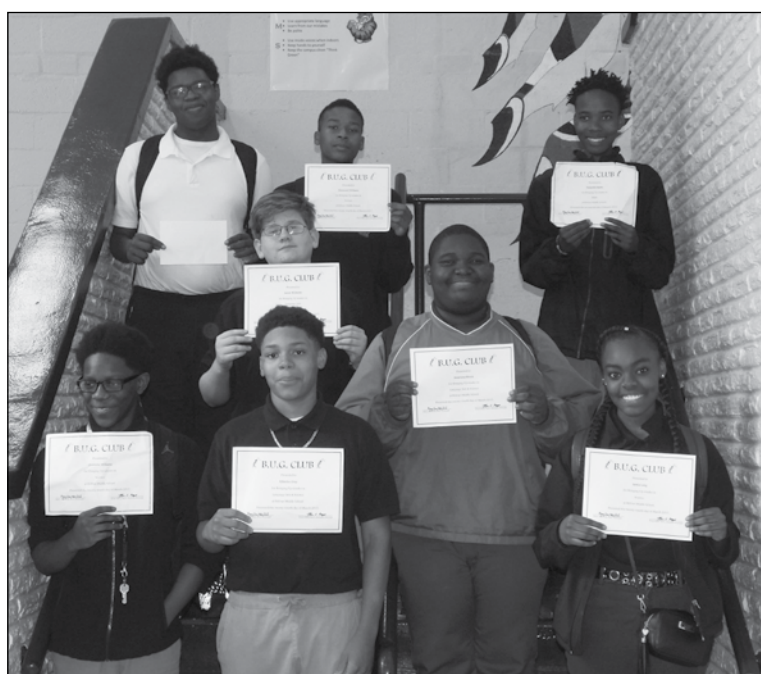

The Town of Toone Makes a Find by Calley Overton



Toone has a new, unique addition to its landscape: an old metal calaboose. Until recently, this piece of Toone history was deteriorating and used for storage in the backyard of a late Toone resident. Now it temporarily resides in the parking lot of the Toone City Park. The plans for the time weathered calaboose are to restore and permanently place it in the park as an attraction.

The two-cell, open-air jail was purchased in 1937 from Madison County and was used until the 1960s.

This June marks the 80th anniversary of Toone's ownership of the calaboose. Back when Toone was a bustling railroad town, it sat on the literal other side of the tracks, behind where the Toone Post Office is today.

Lessons from the Garden by Carolyn Tomlin

The dew had almost dried on the warm Tennessee spring morning. After long winter hours of studying the Old Farmer's Almanac and finding the right phase of the moon, my dad chose this Saturday to plant the family garden.

Dad added fresh gasoline and checked the oil in the 1950s Troy-Bilt tiller. A few sputters and clinks later, the motor churned, caught and pulverized the soil.



Soon, the sweet smell of fresh-turned earth permeated the country air.

Spreading a wagon load of dried manure and turning it under, he was ready to lay out the rows in an east to west direction. This is where I came in. Breaking a short stick from the backyard pear tree, I unwound a ball of string collected over the winter. Cutting and tying one end to the stick and pushing it into the top of the row with the opposite end approximately 50 feet below would make for a straight furrow.

Standing at the end with both hands on his hips, Dad surveyed the row. "Make your first row straight and the others will follow. Allow space between rows. Too close and you can't plow between the plants. Too much, and ground space is wasted."

Mother and Aunt Jessie opened the Mason jars holding last year's seeds. Carefully preserved in the GE chest freezer, the seeds were another means of frugal living. "You reap what you sow!" remarked Aunt Jessie as she carefully opened the small envelopes enclosed in the jars.

The first row planted was marigolds. The age-old custom of companion planting, a relationship of plants to insects, kept the garden free of aphids. Other than being a deterrent to pests, the flowers gave Mother something beautiful to focus on during the long hours of gathering vegetables. And Dad carefully tended the flowers as a way of showing love for his wife.

Looking at all the seeds and the long rows to plant, I could relate to my friends who were given the job of planting black-eyed peas. After the first long row, they surmised how long it would take to finish the task. Plus, crappie were biting and the creek was nearby. So instead of planting rows, they dug one hole and buried all the peas. They never realized that in just a week or so, the peas would all sprout and appear in one place - surely a lesson, "That your sins will find you out."

Next came two rows of Fordhook lima beans. Unbeknownst to me, my dad slipped three or four purple butter beans to the row. When gathering time came, in my childhood innocence, I would shell for hours in hopes of finding the purple beans. The prize meant verbal congratulations from relatives who came to shell and for me, a nickel prize - once, even a quarter!

Even in the spring, the noon sun bore down on our straw hats and T-shirt clad shoulders like warmth from a sizzling steam iron. From the top of the garden, Dad signaled a break. To make planting the garden a treat, Mother prepared a picnic basket of fried chicken, hoop cheese, homemade bread and lemonade.

Just before sunset, our weary eyes surveyed the spring ritual. A multicolored sky floated over the barbed wire fence. Dad's eyes caught the sun's reflection. "Red sky tonight, sailor's delight," he said, smiling. "Red sky in the morning, sailors take warning." Picking up the empty envelopes of seeds, he finished the line: "Rain's comin' by morning!"

Lessons learned from the garden not only sustained my early years but also became character-building traits. And gardening, like other values we teach future generations, continues the legacy of learning from the Good Earth.
