



A Good Walk Enjoyed by Paul Steinsultz

The EMS building in Bolivar turned temporary shelter for a gentleman who is seeing America the old fashioned way. William Smith is a wildlife photographer that has taken on one of his life's biggest challenges: walking across America. Deciding to make the trip last April, the Coast Guard and Air Force Veteran began his journey from Astatula, Florida on July 15, with hopes of reaching the Santa Monica Pier in California.

Mr. Smith stated that he has been overwhelmed by the outpouring of generosity from people he has met on his trek across America. Smith said that he has driven through much of America, but wanted to see our country from a different perspective: on foot. In addition to taking some impressive wildlife photos, he said that he has also changed his perspective on people. He shared that before he left on this quest, he had a cynical view of people and felt disillusioned by them. The scenery of wildlife around him, and seeing people in a different light, has made the trip worth it, so far, he shared.

To date, Mr. Smith has traveled alone, though he said he doesn't really get lonely for companionship. He stated that he misses his daughter and grandchildren terribly, and does look forward to seeing them once his journey is complete. "I have their full support." He said. "I wouldn't have done this if I didn't." He also said that anyone is welcomed to join him, and that he was surprised that some have expressed their desire to do so. He said that he was as shocked by that as he was with the inspiration people get from his journey across America. "I just don't understand it", he said. He further stated that it is quite humbling to be told that.

Imagination Library Gets Needed Help

The Hardeman County Imagination Library (IL) received news they will benefit from a statewide donor as Delta Dental of Tennessee awarded a challenge grant of \$2,000 to the local effort.

Managed by local volunteers, Hardeman County Imagination Library gives all children, from birth to age five in Hardeman County, the opportunity to receive one high-quality, age-appropriate book each month in the mail—at no cost to families. Fifty-seven percent of the county's total eligible population, 861 children, are enrolled in the program and receive books monthly.

The IL is available to all age-eligible Tennessee children through a unique, public-private partnership with GBBF, Dolly Parton's Imagination Library and affiliate programs in each of Tennessee's 95 counties. With vital financial support from the Tennessee General Assembly, foundations, and corporate sponsors, the program funds half the cost of books for enrolled children in each of Tennessee's 95 counties, with the county raising the other half.

"We know the Governor's Books from Birth Foundation positively impacts the literacy level of young Tennesseans and we proudly support their efforts across the state with Bigger Smiles Grants," said Dr. Phil Wenk, President and CEO, Delta Dental and board member for Governor's Books from Birth Foundation.

With over 861 books now being mailed to enrolled children in Hardeman County, the monthly shared cost allocated to Hardeman County Imagination Library exceeds \$890.

Salt of the Earth: Sermon on the Mount-Part 1

by Jeff Capshaw

The Sermon on the Mount contains some of Jesus' most memorable teachings. People of all faiths—and even those with no faith—may have a casual awareness of them. They probably know the Golden Rule, about turning the other cheek, not being judgmental and so on. In the next weeks, I will selectively comment on the sermon's teachings, because most of us forget the simple-Jesus-stuff, the “nuts-n-bolts” of being his disciples.

As a unit, Matthew 5-7 has a long interpretive history, but I will forego all that and assume that Jesus intended the message for anyone, anywhere at anytime who claims to be his disciple. Matthew 5:1 clearly says, . . . *and when he sat down, his disciples came to him* (ESV).

Since Jesus is the King of a Kingdom, and since his disciples are the subjects of that Kingdom, then they need to know how they should think and behave. Consequently, the Sermon on the

Mount shows us what Kingdom living ought to look like. Clearly the sermon provides Christians with a body of ethics by which they ought to live.

For now, I will bracket-off the Beatitudes and begin with Matthew 5:13: being salt. Jesus says, *you are the salt of the earth, but if salt has lost its taste, how shall its saltiness be restored? It is no longer good for anything except to be thrown out and trampled under people's feet.* There are various interpretations of the salt metaphor, and all relate to salt's many purposes in antiquity: as a preservative, a taste enhancer and even as a disinfectant.

Certainly, Christians should have a preserving, enhancing or even a disinfecting affect on culture. Moreover, in the Old Testament, salt was sprinkled into certain sacrifices (perhaps indicating its preserving quality) signifying the perpetuity of God's covenant with his people (Leviticus 2:13). While

these and other points of similarity may apply, they may also miss Jesus' main point. Salt without saltiness isn't of much value or use (v.13b).

Thus, if Christians are not consistently walking-out their true identities, then neither will they be useful in God's Kingdom. Instead they will be about as useful as worthless salt strewn on the walkway.

Next week we will consider Jesus' light metaphor in the statement: *you are the light of the world.* Together, these images create a big picture of Kingdom living, while the sermon's individual exhortations tease-out the details of not being like worthless salt, but rather being like light in a dark world.

Review Your Fixed-income Strategy as Interest Rates Rise

When interest rates rise, the value of your fixed-income investments, such as bonds, will typically fall. If this happens, how should you respond?

First of all, it's important to understand this inverse correlation between interest rates and bond prices. Essentially, when interest rates rise, investors won't pay you full price for your bonds because they can purchase newly issued ones that pay higher rates. So, if you sell your bonds before they mature, you could lose some of the principal value.

You may be seeing a price drop among your bonds right now, because interest rates generally rose in 2018 and may continue to do so in 2019. While you might not like this decline, you don't necessarily have to take any action, particularly if you're planning to hold these bonds until maturity. Of course, you do have to consider credit risk – the chance that a portion of the principal and interest will not be paid back to investors – but unless the bond issuers default, which is usually unlikely, particularly with investment-grade bonds, you can expect to receive the same regular interest payments you always did, no matter where rates move.

Holding some of your bonds – particularly your longer-term ones – until they mature may prove useful during a period of rising interest rates. Although long-term bond prices – the amount you could get if you were to sell these bonds – tend to fall more significantly than short-term bond prices, the actual income that longer-term bonds provide may still be higher, because longer-term bonds typically pay higher interest rates than shorter-term ones.

To preserve this income and still take advantage of rising interest rates, you may want to construct a "bond ladder" consisting of short-, intermediate- and longer-term bonds. Because a ladder contains bonds with staggered maturity dates, some are maturing and can be reinvested – and in a rising-rate environment such as we're currently experiencing, you would be replacing maturing bonds with higher-yielding ones. As is the case with all your investments, however, you must evaluate whether a bond ladder and the securities held within it are consistent with your objectives, risk tolerance and financial circumstances.

You can build a bond ladder with individual bonds, but you might find it easier, and perhaps more affordable, to own bond-based mutual funds and exchange-traded funds (ETFs) that invest in bonds. Many bond funds and ETFs own a portfolio of bonds of various maturities, so they're already diversified.

Building a bond ladder can help you navigate the rising-rate environment. But you also have another incentive to continue investing in bonds, bond funds or ETFs – namely, they can help diversify a stock-heavy portfolio. If you only owned stocks, your investment statements would probably fluctuate greatly – it's no secret that the stock market can go on some wild rides. But even in the face of escalating interest rates, bond prices generally don't exhibit the same sharp swings as stocks, so owning an appropriate percentage of bonds based on your personal circumstances can help add some stability to your investment mix.

As an investor, you do need to be aware of rising interest rates, but as we've seen, they certainly don't mean that you should lose your interest in bonds as a valuable part of your investment strategy.

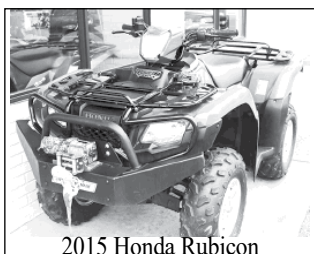

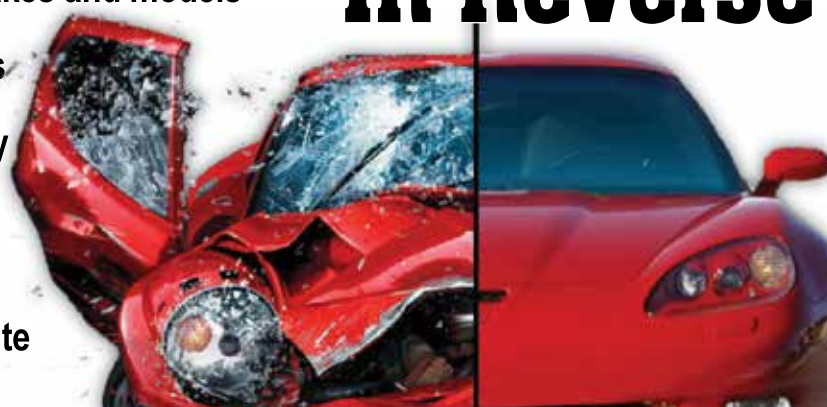
