Hardeman Adoptable Animals is continuously working to ensure that 2019 is the year that we finally move into our forever home! We want to share another update with the community and our supporters. We have made significant progress in preparing the site for a drainage system and concrete slab. The metal building (see photo) will be located on the concrete slab, and this building will house the dogs. This setup will provide a sanitary place for the dogs to stay. This will lead to less cleaning time for volunteers and happier, healthier dogs.

HAA would like to thank Ricky Ayers for completing the electrical work on the administration building. It has been rewired and now has a new working meter! This is a huge step in our progress toward getting the concrete slab poured for the new metal building. The next step for the administration building is have a new HVAC system installed. This is scheduled to take place at the end of March. Then we can start on plumbing and get a working well. The immediate future plans include: completing the administration building, and having a kennel building erected, closed in, inside walls finished (dog proof), and then we can begin furnishing the kennels and work rooms inside.

We know that we still have a lot of work ahead of us, but we have made significant progress. We have saved about 4,000 dogs from Hardeman County since 2011, and we will be able to continue this work in a more efficient and safer way once we are able to move into the new shelter. We cannot do this without the support of our community. Thanks to all who continue to support us in our efforts. 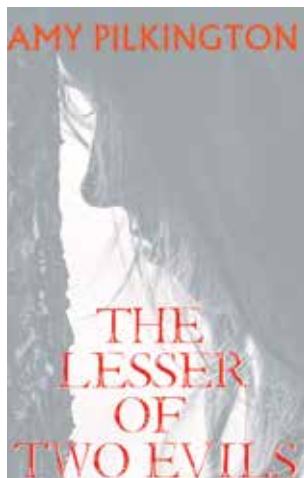

the weather was nice, so it would work for a little while. I assumed it was safe and slept there during the daytime.

A local gas station had a bathroom at the back of the building that was never locked. When the last friend left to go home each night, I would drive to the gas station before it opened. I parked by the bathroom door to keep the car close while I went inside to wash up. After I was done, I would drive over to my parking spot, roll down the windows, and sleep in the front seat with the keys in the ignition. That's what I did for weeks. I lived in my car. It was the only way I could avoid him and stay safe, or so I thought.

Pilkington, whose series on pinup girls of World War II spent time on best-sellers lists in five countries on four continents has also been published in Huffington Post, Health Magazine, USA Today, Grown and Flown, and many others, plans to use the book to help others break free from the silence.

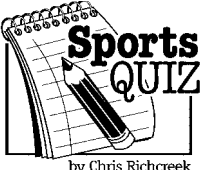

Homemade Carrot Raisin Salad

Ingredients

- ½ cup raisins
- 1 cup warm water or apple juice (or use leftover pineapple juice)
- 1 small can of pineapple tidbits, drained
- 1-pound carrots
- ½ cup mayonnaise
- 1 tbsp granulated sugar

Instructions

- Put raisins in a cup of very warm water (or warmed up apple juice) so they plump back up. Once they plump up, drain water or juice. Drain pineapple of excess juices.
- Peel carrots and then grate them. If making a double batch of this salad, it may be faster to use the grater on your food processor.
- In a medium bowl, toss grated carrots with mayo and sugar. Then add in raisins and pineapple and stir until combined. Cover and put in the fridge to chill thoroughly.
- Give it another good stir before serving.

According to court documents, the timing of the funding for the political hit on then Whiteville Police Chief John Doolen was consistent with money gained from the Ponzi scheme.

Put Together a Professional Team to Help You Reach Your Goals

As you work toward achieving your goals in life, you will need to make moves that contain financial, tax and legal elements, so you may want to get some help – from more than one source.

Specifically, you might want to put together a team comprised of your financial advisor, your CPA or other tax professional, and your attorney. Together, this team can help you with many types of financial/tax/legal connections.

For starters, you may decide, possibly upon the recommendation of your financial advisor, to sell some investments and use the proceeds to buy others that may now be more appropriate for your needs. If you sell some investments you've held for a year or less and realize a capital gain on the sale, the gain generally will be considered short-term and be taxed at your ordinary income tax rate. But if you've held the investments for more than a year before selling, your gain will likely be considered long-term and taxed at the lower, long-term capital gains rate, which can be 0%, 15% or 20%, or a combination of those rates.

On the other hand, if you sell an investment and realize a capital loss, you may be able to apply the loss to offset gains realized by selling other, more profitable investments and also potentially offset some of your ordinary income. So, as you can see, the questions potentially raised by investment sales – "Should I sell?" "If so, when?" "If I take some losses, how much will they benefit me at tax time?" – may also be of importance to your tax advisor, who will need to account for sales in your overall tax picture. As such, it's a good idea for your tax and financial advisors to communicate about any investment sales you make.

Your tax and financial advisors also may want to be in touch on other issues, such as your contributions to a retirement plan. For example, if you are self-employed or own a small business, and you contribute to a SEP-IRA – which is funded with pre-tax dollars, so the more you contribute, the lower your taxable income – your financial advisor can report to your tax advisor (with your permission) how much you've contributed at given points in a year, and your tax advisor can then let you know how much more you might need to add to move into a lower tax bracket, or at least avoid being bumped up to a higher one. Your financial advisor will be the one to recommend the investments you use to fund your SEP-IRA.

Your financial advisor can also help you choose the investment or insurance vehicles that can fund an estate-planning arrangement, such as an irrevocable living trust. But to establish that trust in the first place, and to make sure it conforms to all applicable laws, you will want to work with an attorney experienced in planning estates. Your tax professional may also need to be brought in. Again, communication between your various advisors is essential.

These are but a few of the instances in which your financial, tax and legal professionals should talk to each other. So, do what you can to open these lines of communication – because you'll be one who ultimately benefits from this teamwork.

Secret Religious Practices-Sermon on the Mount: Part 9

by Jeff Capshaw

In this chapter, Jesus teaches some Christian practices must be conducted in secret. By secret, it is doing something not meant to be known or seen by others. Matthew 6 concerns three secret religious practices. The first secret practice is giving. Jesus called it “practicing righteousness” or the giving of alms (food or money) to the needy. He said, “thus when you give to the needy, sound no trumpet before you, as the hypocrites do in the synagogues and in the streets, that they may be praised by others. Truly, I say to you, they have received their reward” (6:2). The Pharisees (the spiritual elites of Jesus’ day) were known for practicing religious duties just for show. It would be like writing a check to a church in order to brag about it, not because of a need God placed on the giver’s heart. According to Jesus, however, “. . . when you give to the needy, do

not let your left hand know what your right hand is doing, so that your giving may be in secret. And your Father who sees in secret will reward you (6:3-4). The second secret religious practice is prayer (6:7-14). Here we find the Lord’s Prayer, the model prayer for believers. Certainly, believers may practice public praying, and that is not necessarily hypocritical. Jesus’ point, however, is that praying “just” to be seen of men is hypocritical. Instead, he urges believers to pray to their Heavenly Father in secret, and He will reward them openly. Furthermore, Jesus said, “and when you pray, do not heap up empty phrases as the Gentiles do, for they think that they will be heard for their many words” (6:7). Thus, short prayers uttered to God in secret from the heart are more effective than long, insincere prayers in public for a show. Finally, Jesus teaches that fasting

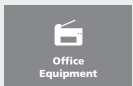
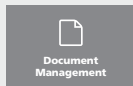

of Bolivar attempt to correct, submit changes, or disagree on any changes to the plans.”

“We never got a notice of any changes,” says Price. “We never were consulted on changes. But it’s not so much that he changed things, it’s that he just didn’t do some things that were in the plans at all.”

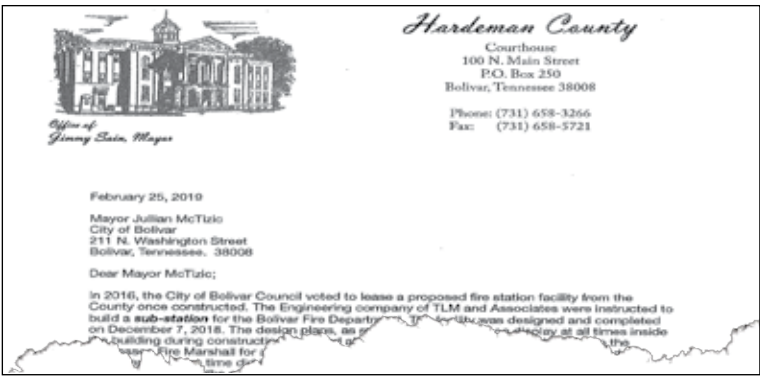
Sain said in his letter that, “Chief Price and Sarah Rice toured the facility frequently as it was constructed.”

Price says that was not the case. “My first look,” said Price. “Was after the walls were up and the concrete was already laid with no drainage.”

Chief Price says his duty was to the city to make sure the city council knew what they were getting versus what they needed.

“We decided to bring in the University of Tennessee Municipal Technical Advisory Service (MTAS) to tell us what a fire station needed to have. They were impartial and gave us the list that we gave to the county. We wanted to be sure of what we were getting before we moved in.”

The story of the partnership between the city and county began in 2015, when the City of Bolivar



Industrial Board voted in February to donate the land in the Bolivar Industrial Park for the project, the Bolivar City Council voted to pay up to \$500 for planning for the facility during their March 2015 meeting. The council then voted unanimously, in July of 2015, to approve a lease agreement between the city and the county.

Current city council members present at the July meeting and approving the measure were Tracy Byrum, Todd Lowe, Suzanne Rhea, and Larry McKinnie. Julian McTizic, a city councilman at the time, was not at that meeting. And according to McTizic, who replaced Barrett Stevens as mayor in 2017, the lease agreement was never signed.

In December of 2018, the county opened the 22,400 square foot fa-

cility, built at a cost of approximately \$980,000, for an EMS/Fire Station annex combination building, but Bolivar balked at completing the deal, citing an inadequate workspace, including lack of floor drains, for the fire station and a need for more work to be done to get it ready for them, using a report from the University of Tennessee Municipal Technical Advisory Service (MTAS) as their guide.

The MTAS report, dated December 2018, highlighted the changes needed, such as 1. Drains in the apparatus bay floors, 2. A slip resistant apparatus floor, 3. No asphalt and no concrete apron at the apparatus bay exit, and 4. The lack of a straight path from the parking lot to the road. Twenty-three other suggested changes were in the MTAS report.

Residents of Hardeman County are invited to share their thoughts on what makes it easy and what makes it hard to eat healthfully and be physically active.

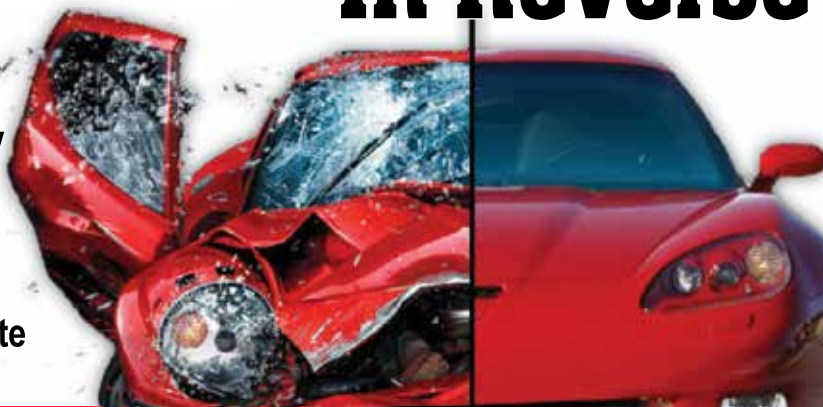

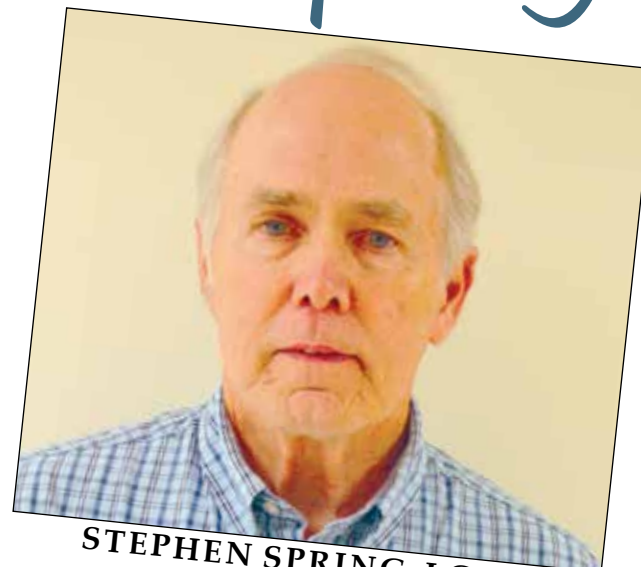
